NEIGHBORHOOD REMINDERS

- *Remember trash cans should <u>not be visible</u> from the street. This is written into our Covenants as, "All garbage and trash storage must be screened from the view of the public until placed for collection." - *If you see an <u>unkept yard</u>, ask your neighbor if they need help. If that doesn't work, contact the City of Edmond code enforcement.
- *Please don't move <u>trees or limbs</u> on HOA property outside the view of our landscaping company or they won't be picked up.
- *Dozens of homeowners still haven't paid their yearly HOA dues. This must be done or a lien will be placed on the home. Late notices have been sent out to those who haven't paid yet.
