- II. Attendance Rollcall and Establishment of Quorum (all present except Meg Robinson, Angi Gavin. Members also in attendance: Anville Francis)
- III. Approval of April 2021 Minutes
 - a. Scott motioned to approve, Bill seconded motion, motion approved with all in favor
- IV. Treasurer's Report
 - a. All Dues are paid in full
 - b. Scott reviewed the financial overview that was sent out in the Summer newsletter
- V. Grounds Report
 - a. Pond Project Update
 - i. Jeremiah, project manager with Turn Pro Aquatics presented solution to dam leakage problem
 - ii. Valerie motioned to approve pond dam fix by TurnPro Aquatics with Bentonite and dirt/ clay mixture up to cost of \$2,000. Motion seconded by Scott, approved with all in favor
 - b. Restore Steeplechase Initiative
 - i. Pitzer work and quotes

- 1. Priority Area 1 (East Entrance, Ponds, Pool, Park area) complete @ cost of \$3,223
- 2. Priority Area 2 (Steeplechase- Grand National trail area) awaiting completion
- 3. Next Priority
 - a. Will ask Pitzer to remove debris from dam area
 - b. Will speak with Pitzer and Gosiak regarding further trail maintenance projects during off- season (fall or winter)
- ii. Tree trimming/ Tree Removal projects
 - 1. Steeplechase- Grand National Trail AND Palomino Trail area complete @ cost of \$4,500
 - 2. Estimate for Palomino Trail Brush Removal (pushing brush back approx. 5-6 feet along Palomino- River Downs Bridge) @ \$2,500
 - a. We will seek to have more work done during off-season
- iii. Bridge Work- Randall Thompson
 - 1. Randall will research bridge repairs vs replacement with composite wood
 - 2. Randall and Ben will make adjustments to bridge with to allow double strollers but not golf carts to fit through
- iv. Funding Raising Dues Ben Winter
 - Discussed ideas for dues increase to be put up for vote this year: maintenance costs rising, contract costs rising, Reserve fund will fall to approx. \$30,000 by end of year (down from \$57,000 at beginning of year), need dues increase to continue level of service and maintain appearance/ useability of common spaces
