- IV. Treasurers's Report April Monthly Financial Report sent by email
 - a) Tom Finley's resignation as Treasurer and Board Member effective May 31st accepted

VI Pool Report

- c) Compliance letters and emails detailing the new restrictions were sent out to everyone in the neighborhood. Signs posted at the pool.
