- I. <u>Call to Order</u> Josiah Ritner as 2022 President
 - Called to order at 7:05 p.m.
 - Quorum established (9 out of 9).

II. <u>February/March Meeting Minutes</u>

- Josiah moved to approve February/March meeting minutes.
- Randall seconded motion.
- All present voted in favor of motion.
- III. Discussion Regarding Pool Bids
 - Randall reached out to 9 companies for pool bids; only heard back from 2-3.
 - ASP's bid was for \$22k and included changing the cartridge filters to sand (not necessary), included price for salt, maintenance 3x/week.
 - Clear Blue Pools had a similar maintenance fee for 3x/week, but the HOA can purchase the stabilizer and salt for \$480/pallet (we need 2 pallets) to reduce costs; \$600 to convert baby pool to salt. Total bid is closer to \$6k.
 - Josiah moved to approve contract with Clear Blue Pools for around \$6k.
 - Randall seconded motion.
 - All present voted in favor of motion
- V <u>ARB Requests</u>
 - New pool approved for new residents moving into 2701 Harness Creek; Randall or Scott will let them know they can proceed.

- Liz to approve new roof at 3900 Derby Run Drive.
- VI. Discussion Regarding Lawn and Grounds Maintenance
 - Pitzer wants an additional \$700 for costs of materials increase in order to plant the flower beds.
 - HOA has already paid \$1k for flowers, and the contract says how many flats/flowers will be planted. No additional money will be paid. Josiah will respond.
- VII. <u>Bridge Repair</u>
 - Bridge repair is being tabled for now. We may be able to cover bridge repair with the money we will be saving with the new pool contract.
 - HOA members will inquire as to any Steeplechase residents who may be in this line of work.
 - Will revisit bridge repair at next meeting.
- VIII. <u>Miscellaneous/Social</u>
 - Decided on May 14 for garage sale. Josiah to include info on website/Facebook; someone will put up sign in neighborhood.
 - Egg hunt is Saturday, April 16 at 2:00. We only have a couple volunteers; if we do not get more signed up, HOA members will need to step in.
 - Scott got a call to pay an invoice for an exterminator for treating the pool house, but no one actually let a company in to spray. It is unclear whether a service was actually performed. Nothing will be paid without proof of service and an invoice. Scott will follow up.
